PRODUCTS WERE SOLD INTERNATIONALLY UNDER THE TANANA SILK BRAND AND LOCALLY AT SEPALIM'S HEADQUARTERS. THE TEAM IN MADAGASCAR ALSO PILOTED THE USE OF INVASIVE WATER HYACINTH AS A CARBON-NEUTRAL FUEL FOR DYEING AND COOKING, WHILE FARMERS EXPANDED NATIVE TREE PLANTING EFFORTS-PLANTING OVER 40,000 TREES TO SUPPORT SILK PRODUCTION, RAFFIA HARVESTING, AND LOCAL CONSTRUCTION NEEDS.
